This announcement is made by E Lighting Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board of directors (the “**Directors**”) of the Company (the “**Board**”) wishes to inform the shareholders and potential investors of the Company that, based on a preliminary review of the Company’s draft unaudited consolidated management accounts for the six months ended 30 September 2023 (the “**Period**”), the Group is expected to record a net loss attributable to owners of the Company of not less than HK\$500,000 as compared with a net profit attributable to owners of the Company of approximately HK\$2.2 million for the six months ended 30 September 2022. Based on the relevant information available, the Board considers that such changes were mainly attributable to (i) the adverse impact in sales caused by the continuous weak retail sentiment in Hong Kong; and (ii) employment support scheme government grant for the six months ended 30 September 2022.

The Company is still in the process of finalizing the Group’s results for the Period. The information contained in this announcement is only based on the preliminary assessment by the Board with reference to the unaudited consolidated management accounts of the Group and the information currently available, and is not based on any figures or information which have been audited or reviewed by the auditor or the audit committee of the Company. Actual results of the Group for the Period may be different from those disclosed in this announcement. Shareholders and potential investors of the Company are advised to read carefully the results announcement of the Company for the Period, which is expected to be published on 9 November 2023.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
